2] **AND WHEREAS**, in accordance with Chapter 3 of the said Rules of the University, Internal Committee at Off Campus Centre of Symbiosis International (Deemed University) at Bengaluru was constituted vide Notification No. SIU/ U-28/ 831 dated 24<sup>th</sup> June, 2019;

3] **AND WHEREAS**, the tenure the Internal Committee at Off Campus Centre of Symbiosis International (Deemed University) at Bengaluru constituted vide Notification No. SIU/ U-28/ 831 dated 24<sup>th</sup> June, 2019 and reconstituted from time to time has come to an end on 23<sup>rd</sup> June 2022;

The tenure of the student member(s) shall cease as and when they cease to be the student of the Institute/ Department/ University.

The tenure of the faculty member(s) and non-teaching employee(s) shall cease as and when they resign from their services or is transferred to another Campus/ Location.
